## WHAT DOES THE FUND INVEST IN?


The Fund provides investors with long-term growth by investing primarily in a diversified portfolio of global investments that are in accordance with Islamic investment principles.

# HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. 


## HOW HAS THE FUND PERFORMED?

#### Year-by-year returns

### 2. Fund expenses

As of December 31, 2015, the Fund's expenses were 2.85% of its value which equals \$28.50 for every \$1,000 invested.

### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and advice that your representative and their firm provide to you.

Global Growth Assets Inc. pays the trailing commission to your representative's firm. It is paid from the Fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.




